



# LIFE MEMBERSHIP CRITERIA AND NOMINATION FORM

## CRITERIA (guidelines) AND APPLICATION FOR NOMINATION PROCESS

### CONSTITUTION

A Life Member is a member of long standing, who has rendered meritorious service and who has been recommended to a General Meeting by the Board and elected by a majority of Members present at the General Meeting who are entitled to vote. Life Membership criteria will be as determined by the Board from time to time. Life Members will not be subject to an annual membership fee. Such members will have full voting rights and may hold office. Life Members will hold membership for their life or until such membership is revoked by a majority of Members present at a General Meeting who are entitled to vote.

### CRITERIA (guidelines)

The board has determined at a meeting on the 18th December 2014 To be to nominated as a life member of the Bunbury Basketball Association the nominator must demonstrate that the nominee has provided outstanding service which is characterised by either/or;

1. Continual and ongoing outstanding commitment and service of commendable and regular personal input over a significant period (not limited to but generally expected to be greater than 7 years) that results in the association being substantially, demonstrably and positively enhanced by that contribution.
2. 150 representative and/ or senior games in the Associations A Grade competition in addition to being a positive contributor to the association in some form of non-playing role over a significant period of time. (not limited to but generally expected to be greater than 7 years)

### HOW TO NOMINATE

1. Nominator is to complete the attached nomination form and attach a current photograph of the nominee.
2. The nomination must be seconded.
3. This is to be submitted to the Secretary of board of the Association who will present to the board.
4. The board will then vote on whether they will accept the nomination and submit to a General Meeting of the Association where it must be passed by a majority of those present. It is preferred that life member nominations are referred to the Annual General Meeting held in October each year. This means that nominations would need to be made no later than end of August in time to be accepted by the board for submission.
5. The board may also choose to call a Special General Meeting to vote on a life membership application by giving 14 days' notice in writing if there is an urgent nomination to be considered.
6. Nominations that the board does not support will be advised to the nominator within 7 days of the board meeting. Unsuccessful nominations will be advised to the nominator within 7 days of the general meeting. Unsuccessful nominees can be re-submitted in following years.

### APPROVAL AND BENEFITS


1. On Approval of the Life Membership the secretary of the association will order a life member badge, print and frame a life member certificate and arrange the presentation of the life membership at a special or upcoming event. The Life member will be added to the life member board, register, the association website a. Life members shall be invited to all significant and milestone events of the club and all Annual General Meetings.
